Plaintiff Microsoft Corporation ("Microsoft"), by counsel, pursuant to Federal Rules of Civil Procedure 55(b)(2), 53, 65(a) and (c), the Computer Fraud and Abuse Act, 18 U.S.C. § 1030, Electronic Communications Privacy Act, 18 U.S.C. § 2701, Trademark Infringement under the Lanham Act, 15 U.S.C. § 1114 et seq., False Designation of Origin under the Lanham Act, 15 U.S.C. § 1125(a), Trademark Dilution under the Lanham Act, 15 U.S.C. § 1125(c), the common law, the All Writs Act (28 U.S.C. § 1651) and the Court's inherent equitable authority, respectfully moves the Court for entry of a default judgment and permanent injunction against John Does 1-2 (the "Defendants").
